Why your US terms don't work in Europe

Internal Investigations: Staying Out of the Sinkhole

The internal investigation into corporate misconduct has a well-deserved reputation as an organizational sinkhole that cannot be managed to deadline or budget. General counsel and independent directors often complain that the investigations they commence are soon hijacked by expanding scope, staffing inefficiency, and a lack of accountability by lawyers, accountants and other retained professionals who frankly have never managed legal problems like business problems. Plus the human cost to management teams who naturally are distracted (and perhaps demoralized) by endless outside scrutiny at a time when the business requires team focus.

Some of this may be inevitable. Urgency, uncertainty, and the concerns of multiple constituents -- regulators, outside auditors, directors, and investors -- do of course make these investigations tougher to predict and manage than periodic securities filings, episodic transactions, and even big-ticket litigation. But proactivity at the outset, followed by close management throughout, will discipline the investigation process -- and accelerate the end.

Join us for a roundtable discussion about when to commence internal investigations -- and how to define the scope and manage all of the moving parts in a disciplined manner that then lends itself to the sort of predictable internal reporting expected of corporate counsel. The focus is on specific techniques -- dos, don'ts and war stories -- to ensure that the internal investigation doesn't inflict more damage on the business than the alleged misconduct that precipitated it.
