Information re 2021 ELC and Select Other Committee Co-Chairs

This information was prepared at the request of ACC NCR Board President NAME and VP of ELC NAME for the sole purpose of considering candidates for the ACC NCR Board, using the following criteria and with input from our support staff (chapter administrators etc):

- **Ready Now:** Consistently demonstrates high potential; ability to move 1 or 2 more levels; shows capability, bandwidth, aspiration, and commitment. Requires a minimum of 2 years of Committee service. Also, contributes to creative/new ideas and has connections to other parts of the chapter.
- **Ready Soon:** Demonstrates significant potential; needs a bit more experience to be ready; shows some (but perhaps not all) of capability, bandwidth, aspiration, and commitment
- **Not Ready:** Contributes value to chapter but lacking in some areas of capability, bandwidth, aspiration, and commitment
- **Unrated:** Too new to be rated effectively
