A very brief history of the San Diego Chapter of the Association of Corporate Counsel

In the Beginning... The Southern California Chapter of what was then called ACCA was formed in 1984. The following year a chapter was formed in San Diego. However, by 1987 the San Diego Chapter had withered and died. Its orphaned members were scooped up by the SoCal Chapter. From that moment on it was painfully obvious that the geography of the SoCal Chapter made unity and member service impossible. (Even today the SoCal Chapter struggles to serve just Los Angeles and Orange counties.) About the only concession the Los Angeles-based Chapter leadership made to their San Diego members was to hold Day at the Races at the Del Mar race track.

Founders. In 1991 and early 1992 some San Diego area general counsels began discussing the formation of a San Diego Chapter of ACC. This group included Jim Edwards then of General Atomics, Dan Hapke then of General Dynamics, Alvin Kalmanson then of NASSCO, Bill Stewart of Cubic, Dennis Stryker of Rick Engineering, and the late Don Wilkins of REMEC.

The current San Diego Chapter was formed in 1992 and had, initially, about 50 members. Jim Edwards was the founding President. Today, the chapter serves over 600 members.

A brief history of the Association of Corporate Counsel (ACC)

Founders. In 1981 and early 1982 some prominent general counsels (GC's) began discussing the idea of a bar association to serve the needs of lawyers who practice in-house in corporations and other private sector organizations. Among this group of GC's were Bob Banks of Xerox, Jack Brigham of Hewlett Packard, John Clute of Boise Cascade, Carl Liggio then of Ernst & Young, Don Walsh of Sun Oil, and Guy Zoghby then of IBM.

Ultimately, 55 GC's were invited to attend an organizational meeting to be held near the Dallas-Fort Worth Airport in March 1982. Fifty-three of the invitees attended. This overwhelming response impressed all that a common chord had been struck. Also in attendance was Thomas Gonser a former in-house lawyer and the incumbent Executive Director of the ABA. Gonser attempted to make a plea for the needs of in-house counsel to be served by the ABA. While some in the group found this idea appealing, a large majority expressed frustration caused by years of actively working within the ABA's structure.

The American Corporate Counsel Association (ACC) was born shortly thereafter and from the beginning it was (and is today) structured unlike any other bar association. There is a national headquarters and staff in Washington, D.C. The staff is headed by a President. There is a global board of directors (all ACC members), the head of which is an elected Chairman. There are also local chapters with their own boards chaired by an elected President. The first chapter was



Colorado, formed in 1982. Each year thereafter, new chapters have been formed and recognized by the global organization. Some chapters are state-wide while many others concentrate on the needs of in-house counsel in a large metropolitan area.

Both the national ACC organization and the local chapters hold Continuing Legal Education (CLE) meetings, engage in advocacy regarding issues of importance to members, sponsor social events and conduct many other activities. In addition to chapters the national organization also has committees that serve the needs of members whose practices include concentrations in specific substantive areas of the law. Some chapters also have committees.

<u>Some Numbers.</u> At the end of 1982 ACC had about 3,000 members. In 1992 it had nearly 10,000 and by 2016 there were over 40,000 members. Today the association boasts over 45,000 members who practice in-house in over 10,000 corporations and other entities in 85 countries.

There are 59 chapters and 19 committees (Global level).

Going International. In 1994 the European Chapter was formed, followed by the Israel Chapter in 2000. More recently, the Canada, China, Argentina and Australian Chapters were formed. The advent of international chapters prompted the association to change its name to the Association of Corporate Counsel (ACC). ACC maintains close ties to in-house counsel and their local associations in many countries including New Zealand.
