ARTIFICIAL INTELLIGENCE: EVOLVING REGULATORY COMPLIANCE ISSUES FOR THE CONSUMER FINANCIAL SERVICES SECTOR

The presenters will discuss the increasing regulatory focus on assessing discrimination and potential fair lending risks associated with AI, including recent efforts by the CFPB to use adverse action requirements to promote greater transparency in AI models and shine a light on risks associated with non-traditional data elements in models used by financial institutions. They will also explore implications of the Biden Administration's recent Executive Order on AI, new legislation and regulatory actions at the state level on AI consumer protections, and related data privacy and cybersecurity issues in the U.S. and from a global perspective. Industry best practices and steps that financial institutions can take to mitigate risks associated with AI will also be discussed.
