- Discuss sponsor satisfaction surveys (how well our events are doing for the sponsors, do they attribute a certain amount of originations to events or ACC sponsorship, and what do they want in terms of ROI)



Membership Committee

Charter – Stimulate interest of eligible candidates for membership by personal contact, descriptive literature, and guest attendance at appropriate Chapter events

Discussion Topics:

- Increase member retention and satisfaction
- Continue to grow membership by a goal of 6%
- > Survey cross-range of current and former members for satisfaction metrics
- Recruit new members via different avenues: corporate membership, in-transition, lapsed members
- > Partner with director of ACC to target MCLE and sponsor events to encourage higher attendance
