- Each nonprofit client screened to identify legal issues and determine eligibility:
 - Nonprofits that serve economically disadvantaged and traditionally underrepresented populations, working primarily in the areas of health and human services, community development, affordable housing, and neighborhood revitalization, as well as arts, civic, and environmental or conservation organizations
 - Expense of hiring legal counsel would significantly impact program delivery
 - The ability to work effectively with a volunteer









Who Can Volunteer?

- Lawyers with a CT/NJ/NY plenary license
- Lawyers with a CT/NJ/NY in-house license
- For NJ matters only, other lawyers who:
 - Complete our one-page certification form and
 - Provide us (1) proof of graduation from an ABAapproved law school and (2) a Certificate of Good Standing from another state or the District of Columbia
- Paralegals, Compliance Staff, and other professionals (in partnership with a lawyer)

- Properly categorizing workers as independent contractors vs. employees; exempt vs. nonexempt
- Issues such as leave administration, disability, staff restructuring

- Trademark registration of name and logo
- Terms of Use and Privacy Policy
