Hello Litigation Network!

Outside of law, I trained in mixed martial arts for over a decade until my body protested, and while I love tennis, it's a similarly "prohibited" activity. And no, I haven't tried pickleball yet—but I'm sure it's only a matter of time.

Today, I live in Petaluma, California, with my wonderful partner, Erica, an artist; our incredible 11-year-old son; four cats who run the house; and a disloyal dog named Essie Davis. Recently, I finished building a duplex, gained hands-on construction experience, co-own and manage a gas station with a friend, and just bought a new small business. Life is an adventure, and I'm always eager to learn and try new things, often finding myself in amusing situations, for better or worse.
