Recognized by ACC Global as the Best Diversity Initiative, the diversity internship program enhances diversity in the legal community by offering underrepresented students high-quality, paid internships. Selected students gain real-world experience in in-house legal departments while host employers connect with promising, diverse law students. ACC Southern California volunteers support interns and host companies throughout the summer to ensure a successful experience.



WHO IS ELIGIBLE FOR THE INTERNSHIP PROGRAM?

Full-time 1L students and part-time 2L students at ABA- accredited law schools in Los Angeles and Orange Counties, in good academic standing, who have a diverse background, are encouraged to apply. For this opportunity, "diversity" is intended to broadly include all underrepresented groups including, but not limited to, ethnicity, gender, physical disability, veteran service or relationship, family and socioeconomic background, and sexual orientation.



The application period for students opens Monday, December 2, 2024. Applications are due by Friday, January 17, 2025.



Employers in the Los Angeles and Orange County area who exhibit a strong commitment to diversity and inclusion initiatives in their organization and in their corporate legal department.

TIMING

Host companies will provide full-time internships lasting 6-10 weeks, over the summer. Interns and employers will collaborate to set a precise schedule.

STUDENT COMPENSATION

The minimum compensation for the law student intern is \$25/hour which should translate to a total of \$6,000 - \$10,000 stipend depending on the length of the program. The host organization pays the student over the course of the 6-10 weeks per the organization's usual payroll practices and timetables.

STUDENT SELECTION

ACC Southern California does all the legwork! After extensive promotion and student outreach, scoring of applications by an internship committee comprised of in-house attorneys and multiple interviews, ACC Southern California will match selected interns with a host organization.

EXPERIENCE

Host companies will provide meaningful legal experience to interns, enabling them to build practical legal skills and working relationships with in-house lawyers. Host companies will determine whether the internship will be remote, in-person, or hybrid. Interns will participate in the daily work of the in-house legal team, will be assigned a mentor within the host company, and will complete at least one drafting assignment appropriate for use in 2L interviews.
