• March 2019 – ACC-STL was a "2019 Justice For All Ball" Gold-Level Sponsor. This is one of Legal Services biggest fund-raisers of the year.



- April 2019 National Healthcare Decisions Day in partnership with Husch Blackwell (<a href="http://huschblackwell.com">http://huschblackwell.com</a>), Legal Services, and Family Care Health Center where volunteers offered a free legal clinic to assist low-income individuals in Missouri with Durable Power of Attorney for Healthcare and Healthcare Directive forms.
- May 2019 -- Veterans Wills Clinic where volunteers filled every volunteer slot and helped 40 veterans and spouses with free legal counsel on wills, living wills and power of attorney valued at \$35,000 or less. The ACC-STL partnered with the Veteran Justice Outreach Program, the VA St. Louis Healthcare System, and Missouri Attorney General's Office Military Assistance Team.
