Types of EU sanctions

Trade sanctions:

- Import restrictions
- Export restrictions
- Applicable to certain goods, services
- · Applicable to dual use items
- Applicable to certain services (technical assistance ..)

Arms embargoes:

- Applicable to items on EU Common Military list
- · Related financing, technical assistance

Financial sanctions:

- Freezing funds
- Financial transactions
- Export credit restrictions
- Investment restrictions

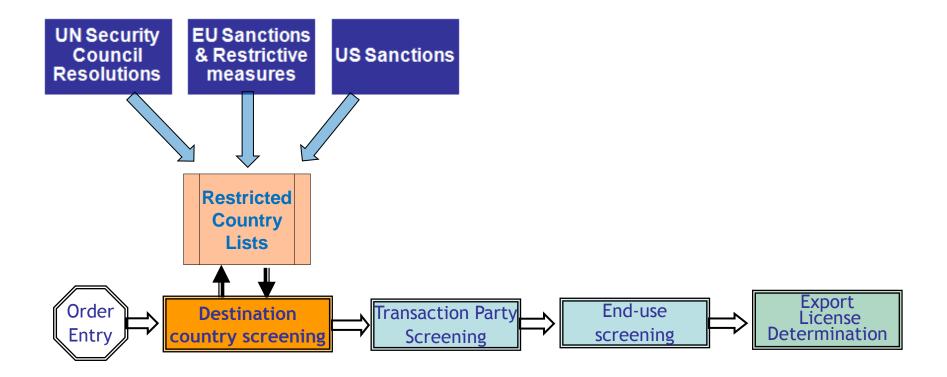
Target non-state entities or natural or private legal persons

Sanction laws compliance through order screening process



Compliance screening: Restricted country lists

Country List 1

- No business allowed
- US EAR country group E
- Other embargoed

- Applicable to entire corporation worldwide? Regional? Local?
- Deviations? (US vs EU subs)
- Take advantage partial embargoes

Country List 2

- Sales subject to prior review
- Sensitive countries
 - On UN, EU & national lists
 - by diversion risk
 - Due diligence report
 - assurances from customersSales approved by Legal ...

Country List 3

- Non-sanctioned countries
- No Review

 subcategory of intra-EU or friendly Annex II countries
 automated screening tool allows 100% screening

Lists decided by Legal & Compliance Dept based on risk assessment including diversion risk, sales territory, jurisdictions, end-users, type of products (strategic, military ...), end-use.....

Sanction programs target also persons

Persons that violated sanction laws / export control laws are blacklisted

Blacklisted Persons are denied certain or all trade privileges

- General trade prohibition or restrictions on trade in certain items and/or certain end-uses
- denial of new export licenses, suspension/annulment of existing export licenses
- not eligible for government bids & contracts

It is prohibited to engage in transactions with a blacklisted Person

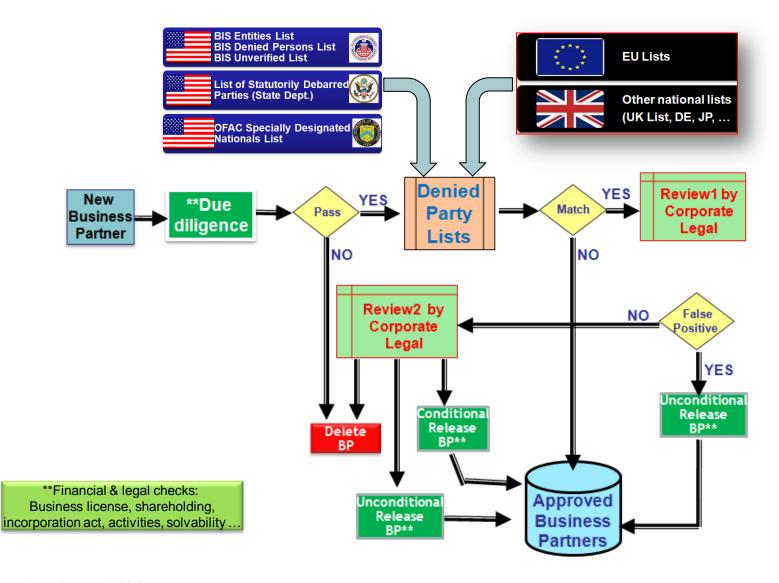
- Some transactions may still be allowed
- Check out the extent of the restrictions in the relevant Denial Order

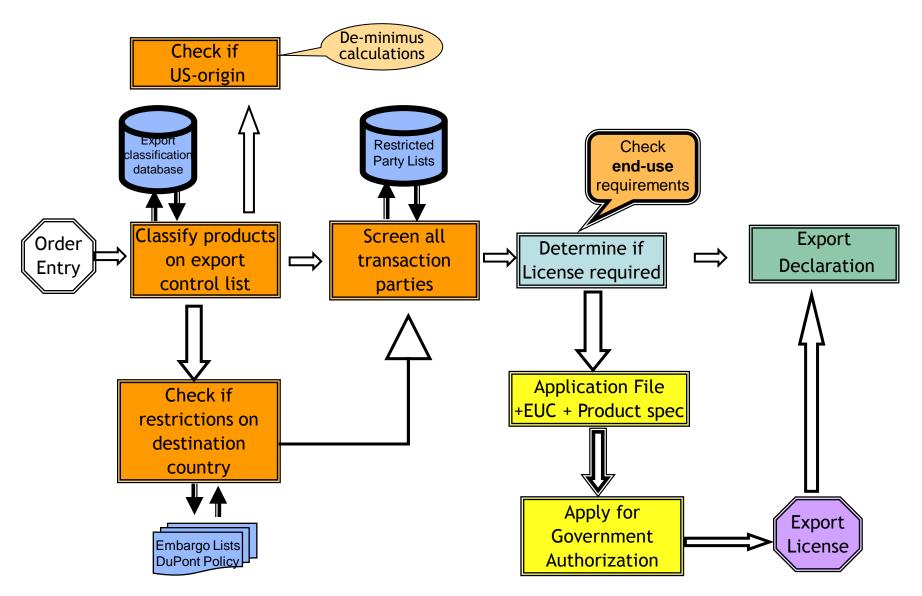
Governments maintain lists of sanctioned parties

Observe also US denied party lists issued by US government agencies

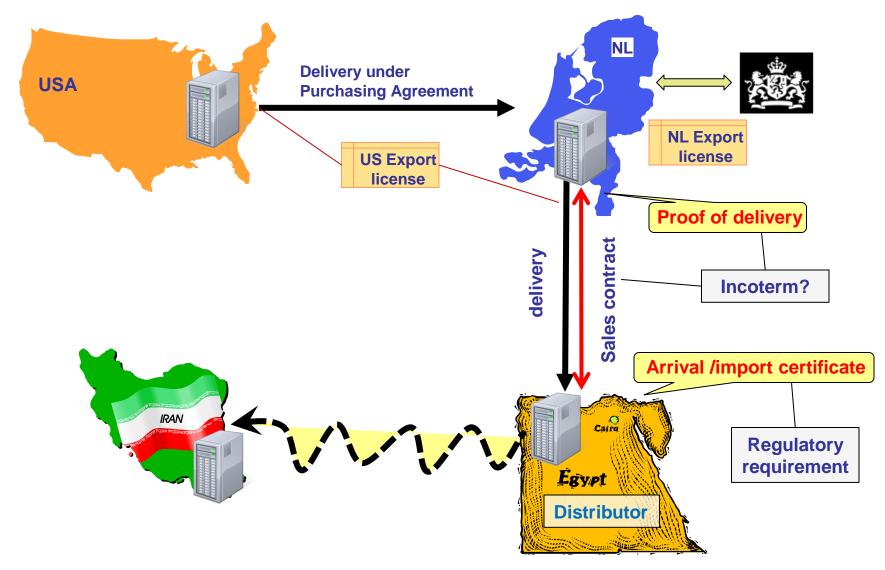
- when importing or re-exporting US-origin items:
- · when transferring US-origin technology
- Some US sanctions apply also to subsidiaries of US-companies (Cuba, Syria sanctions)

Circumventing sanction laws: Diversion



Minimize risk of diversion

Understand the nature of your product and its possible uses

Understand the transaction & post shipment flow

Special attention to global transshipment hubs

- i.e. countries or areas that function as major hubs for trading and shipment of cargo
- pose special risks due to their large volumes of export, transit, transshipment, and import and reexport traffic

Contractual clauses and notices of legal requirements in sales documentation

Screen end-user & check end-use – Red flags checklist

Inquire into customer's compliance program

Provide training on legal requirements

Audit rights or access to documentation
