

NEW YORK — Dominique Strauss-Kahn formally asserted his innocence Monday to charges he tried to rape a hotel maid, but the drama unfolded outside the Manhattan courtroom as protesters jeered the former International Monetary Fund leader and lawyers for the house-keeper said she was eager to testify despite a "smear campaign" against her.

Strauss-Kahn's attorneys offered a rival account of the May 14 encounter at his \$3,000-a-night Manhattan hotel suite, hinting again that the French diplomat might argue the encounter was con-



Greece faces a cash crunch in mid-July and is counting on eurozone finance ministers to release the next tranche of its existing loan before then. The Parliament vote is timed to precede a special meeting of the ministers Sunday, when they will decide whether to release the disbursement.

In opposition to the measures, Greece's two major umbrella unions-private-sector GSEE and public-sector ADEDY-held the first day of a two-day general strike Tuesday, the second such strike called this month, and the fourth this year.

The strike disrupted public and private services around the coun-

try; shut central-government ministries, schools and local government offices; and affected rail, air and ferry services. Schools and universities also were closed as a result of the strike, while hospitals and state-owned companies operated with skeleton staffs. Some bank employees, journalists and pharmacists also staged their own walkouts

"The hundreds of thousands of strikers, the citizens that have taken to the streets around the country, are boiling over with rage and indignation over the new measures," Yannis Panagopoulos, president of the private-sector union, said. "These polices are not only unjust, but are also a dead end and

Although public-sector partici-

pation in the strike was high, a mass rally organized by the unions Tuesday drew only a relatively small turnout, with police estimating that about 20,000 people took

Marinos Malatatis, an unemployed 38-year-old elevator technician who was part of the union protest, said many Greeks were afraid to leave their jobs and join in the demonstrations.

"The turnout is low, and not many people have come," he said. "But with unemployment high-it's now around 16%-a lot of people are afraid of losing their jobs and are trying just to keep their heads


In the fall of 2007, just as <u>Dominique Strauss-Kahn</u> was starting his job as managing director at the <u>International Monetary Fund</u>, he asked all divisional heads to give him presentations on their specific areas of focus.

One briefing was on the fund's activities in Ghana. The fund's operations in the small west African country were minimal. But Mr. Strauss-Kahn took a keen interest in the woman making the presentation — Piroska M. Nagy, a blond

Hungarian-born economist who was 50 at the time and who had worked at the I.M.F. since 1986.

Mr. Strauss-Kahn's subsequent brief affair with Ms. Nagy, who is married, soon became public — spurring an internal investigation at the fund that would ultimately clear him of having abused the power of his office.

Now, in the aftermath of Mr. Strauss-Kahn's arrest on charges that include attempted rape, his past conduct is undergoing fresh scrutiny. A person with direct knowledge of Ms. Nagy's version of what happened and her view of the I.M.F. investigation said that the affair — which was conducted at the World Economic Forum in Davos,

# Defining Loyalties and Interests

- Nagy's husband discovered affair
- Told lovers: "adverse publicity"
- DSK did not go to IMF
- Hired his own lawyer, PR firm
- "Concerned about damage disclosure..."

## Board Divided

- 3 of 24 Board members were informed
- Left DSK in charge
- Approved internal investigation only
- 21 Board members left uninformed

# First Investigation Was DOA

- Nagy refused to cooperate
- Distrusted motives and method
- Lacked support of entire Board
- DSK's shadow

# Second Investigation

- Outside law firm hired
- DSK "formally informed" of cooperation
- Not ordered to cooperate
- DSK "encouraged" others to cooperate
- Chilling cooperation

# Investigation of the Investigation

- Lawyers read IMF standards
- Talked to in-house counsel
- Interviewed 28 IMF employees
- Read documents and e-mail
- Described as "comprehensive and complete"
- Submitted a 9-page report to the IMF board

# Findings

#### Investigators:

- Noted Nagy never filed complaint
- Characterized messages as "consensual"
- "Consensual relationship...short duration"
- Both "actively engaged in the pursuit"
- "Both agreed to...hide...relationship."

### But Were There Others?

- Investigators "reviewed other allegations"
  - "Did not find any evidence to support" them
  - Spent few days at IMF

- Daily Telegraph of London reports
  - Evidence of another DSK affair
  - Married Asian administrative worker

#### "CONCLUSION"

- Invited IMF to "reach its own conclusions"
- After 6 pages of findings, one "Concluding Observation:"
  - Should framework for MD's conduct be higher standard than staff, given "prominence and reputational consequences" consistent with "prevailing best practices?"

#### IMF Board Considers Matter Closed

#### Concluded inquiry October 25, 2008

- Thanked counsel for careful, exhaustive effort
- Made report public
- No harassment, abuse of authority, but regrettable
- And a serious error of judgment
- NO DISCIPLINE

# What Principle Guided the Board?

#### Former IMF official Eswar Prasad:

"The IMF Board felt that at this stage he had taken his lumps" and that any censure would merely serve to undercut DSK's leadership.

# Stand by Your Man

- DSK's wife: "one night stand"
- "We've put it behind us"
- Nagy and husband to London



### DSK's REPONSE



- DSK apologized: "I am committed, going forward, to uphold the high standards"
- DSK told French lawyer to sue rumormongers
- DSK's lawyer: "people who relay rumors without checking anything"

# Nagy on DSK

"Brilliant leader with a vision addressing the ongoing global financial crisis."

But...

"But I fear that he is a man with a problem that may make him ill-equipped to lead an institution where women work under his command."

# Fast Forward to 2011

- DSK virtual alter ego of IMF
- From jail, DSK speaking on IMF's behalf:
  - I want to protect this institution which I have served with honor and devotion

#### IMF Updates Standards for Staff Conduct

May 19, 2011

The IMF has revised its standards of conduct for staff, bringing to fruition more than two years of work on strengthening the institution's ethical framework. The enhanced standards of conduct introduce new reporting requirements on close personal relationships in the workplace and update the institution's policies on harassment and discrimination. They also reinforce protection against retaliation for staff who report suspected misconduct, while clarifying procedures for conducting and overseeing investigations of such misconduct.

The process of updating the standards of staff contact and related disciplinary procedures has been under way since 2009. Led by the IMF's <a href="Ethics Advisor">Ethics Advisor</a>, this work involved broad collaboration and consultation across the institution, including a working group on staff conduct with diverse staff membership, and the Staff Association Committee. The Fund also benchmarked its policies against those of comparator institutions and reviewed best practices in a cross-section of other organizations.

"Clear and well-defined policies and procedures are essential for establishing a strong ethical foundation, and are in keeping with the Fund's commitment to promoting transparency and accountability," said Virginia Canter, a former Associate Counsel to the President of the United States who has served as Ethics Advisor since early 2010. "These standards help create a positive, respectful, and productive workplace."

The updated standards were approved by IMF Deputy Managing Director Nemat Shafik on May 6.

#### More accessible format

The new standards, published as a General Administrative Order of the IMF, display the information in a more concise, clear way, making it easier for staff to find and interpret the institution's rules. This latest periodic review of the IMF's policies and rules on employee conduct provided an opportunity to revamp the presentation of the standards on the institution's website.

The main enhancements to the standards of conduct include:

- a new policy on close personal relationships in the workplace, which requires that a supervisor who has an intimate personal relationship with a
  subordinate report such relationship to the Ethics Advisor, his/her supervisor, or the Human Resources Department to seek resolution to potential conflict of
  interests and workplace fairness concerns. Failure to report and then resolve the potential conflict of interest constitutes misconduct and is grounds for
  disciplinary action.
- a new policy concerning protection against retaliation: retaliation against a staff member for reporting suspected misconduct or participating in the Fund's dispute resolution system has been added explicitly as a form of misconduct;
- greater emphasis on prevention and early resolution in policies on harassment and discrimination. The IMF's policy on harassment, including sexual
  harassment, already made clear that harassment in any form is not tolerated, constitutes misconduct, and triggers disciplinary actions up to and including
  termination of employment, but the new standards of conduct emphasize early action; and

# Don't Shortcut Investigation


- As long as it goes; Board has cover


