Established in 1992, the AT&T employee telework program avoided 87 million miles of commuting (VMT) in 1999, saving 41,000 tons of carbon dioxide, 4.1 million gallons of gasoline, 180,000 tons of hydrocarbons, 1.4 million tons of carbon monoxide and 93,000 tons of nitrous oxide. Recent innovations include team management to find and replicate best practices; an intranet "portal" giving readiness assessments and links to resources; statistical telephone surveys regarding participation, benefits, barriers and environmental impacts; a widely publicized "Earth Day is e-Day" event; and AT&T's Telework Webguide.
