Faculty Biographies

James Comey

James Comey is senior vice president and general counsel of the Lockheed Martin Corporation in Bethesda, Maryland. He is responsible for management of the corporation's legal affairs and law department, including serving as principal counsel to Lockheed Martin Corporation's senior leadership and the board of directors.

Mr. Comey has served as deputy attorney general of the United States and was responsible for supervising the operations of the Department of Justice. Prior to becoming deputy attorney general, Mr. Comey was United States Attorney for the Southern District of New York.

Honorable Sven Erik Holmes

The Honorable Sven Erik Holmes is the executive vice chair, legal and compliance for KPMG LLP, where he directs the office of general counsel, government affairs, security, communications, and the firm's ethics and compliance programs. He is also counsel to the board of directors and a member of the management committee.

Previously, Judge Holmes was appointed by President William J. Clinton as United States district judge for the Northern District of Oklahoma and then as a chief judge. Judge Holmes was a member of the budget committee for the federal judiciary, serving as vice chair, and has taught constitutional law as an adjunct professor at the University of Tulsa College of Law. Before that, he was a partner at the law firm of Williams & Connolly in Washington, DC, where he specialized in transactions, business litigation, and investigations. Judge Holmes was also a staff director and general counsel to the senate select committee on intelligence, vice president of the Baltimore Orioles, and administrative assistant to past Governor David L. Boren of Oklahoma. He served as a law clerk to United States District Judge Thomas R. Brett.

He received his A.B. from Harvard University, J.D. from the University of Virginia School of Law, and LL.M. from Georgetown University Law Center.

Michael J. Holston

Michael J. Holston is executive vice president and general counsel of Hewlett-Packard Company (HP) in Palo Alto, California. He manages the global function responsible for worldwide legal matters including patents and licenses, commercial contracts, litigation, and regulatory matters. He has direct operational and supervisory responsibility for all lawyers in the legal department and manages HP's extensive use of outside legal resources to ensure optimum performance. Mr. Holston oversees HP's efforts in compliance, ethics, and government affairs.

Before joining HP, Mr. Holston was a partner in the litigation practice of Morgan Lewis focusing on complex litigation, primarily defending products liability and consumer fraud class-action lawsuits, and white-collar criminal defense litigation. Mr. Holston is a former assistant U.S. attorney. He served as a prosecutor in the criminal division of the U.S. Attorney's Office for the Eastern District of Pennsylvania.

Mr. Holston is a fellow in the American College of Trial Lawyers and has been acknowledged as one of America's leading lawyers for business. He taught a trial advocacy course at Villanova University School of Law and also taught and lectured on trial advocacy for the National Institute of Trial Attorneys.

Mr. Holston holds a B.S.M.E from the University of Notre Dame and a J.D. from Villanova University.

David G. Leitch

David G. Leitch is general counsel and a senior vice president of Ford Motor Company, in Dearborn, Michigan.

Mr. Leitch has served as chief counsel for the Federal Aviation Administration, overseeing a staff of 290 in Washington and the agency's 11 regional offices. He is also a past deputy assistant attorney general in the U.S. Department of Justice, Office of Legal Counsel. Mr. Leitch's law career includes serving as law clerk to U.S. Supreme Court Chief Justice William H. Rehnquist, and as a partner in the Washington, DC law firm of Hogan & Hartson, L.L.P.

Mr. Leitch served most recently as the deputy assistant to President George W. Bush and the White House's deputy counsel. In his most recent role at the White House, he advised the president and his staff on a variety of legal issues, including issues involving the war on terror, judicial nominations, legislative proposals, and ethics.

Mr. Leitch is an undergraduate of Duke University and a graduate of the University of Virginia, School of Law.
