



In-house counsel may find themselves responsible for overseeing corporate departments that manage, or ought to manage, the risks of international travel for corporate employees. The following is an outline to assist in-house counsel in informing themselves about their corporations with respect to international business travel as preparation for partnering with insurance brokers, underwriters and security service providers.

- I. Determine who in the corporation should advise you as you work to understand and analyze the needs of the corporation and develop a unified approach to managing the risks of international travel.
 - A. Risk Management and Insurance
 - B. Security
 - C. Human Resources (important insight for orientation, training, communication, enforcement)
 - Travel (in-house travel department, corporate owned travel agency, or outside travel agency?)
 - E. Legal
 - F. Compliance
 - G. Management (especially with respect to corporate policy and direction)
 - н. П
 - I. Finance (e.g. possibly with respect to expense reporting guidelines and auditing of travel)
- II. A risk assessment needs to be tailored to the corporation giving consideration to the type of industry, the size of the corporation, the number of people who travel and where they travel, etc. Suggested questions:
 - A. Who travels?
 - 1. Consider employees from all business activities and functions.
 - Determine, how, by whom and where information about international travel by corporate employees is documented.
 - B. Where do people travel?
 - It may take a survey of international travel in the past 2-5 years to get a full picture.
 - 2. Are there business plans available about future travel or future business development to indicate where people may start traveling?
 - C. Why do people travel for the corporation?

Does the corporation provide alternatives to international travel (e.g. telephone conferences, webcasts, video conferencing)?

- D. What are the current corporate policies and procedures involving travel?
 - 1. Who approves travel arrangements prior to trips?
 - 2. Can the company track the location of its employees at any given time?
 - 3. Is there a written travel policy or a written security policy in place?
 - a. how comprehensive is the policy/policies?
 - b. how are the policies communicated?
 - i. a written policy is distributed to all employees
 - ii. the policy is discussed at orientation
 - iii. the policy is presented during training

-what type of training?

*Personal safety training?

*International cultural information

and training?

- how, where and by whom is the training performed?

*in-house

*outside the company

- c. how are the travel or security policies enforced?
- 4. How does the corporation communicate with employees about travel?
 - a. Is there a mechanism to communicate about and enforce travel restrictions to dangerous places?
 - b. Is there a mechanism to communicate dangerous situations that may arise while someone is traveling?
 - c. What is the source of information used for either a or b?
- 5. Is there a crisis response program for international travel?

Does the corporation maintain personal information about employees who travel?

- a. What types of information are maintained?
- b. Where is the information kept?
- c. Who has access?
- d. What measures are in place to keep the information confidential?
- E. What departments/people are currently involved in managing international travel risks and how are they involved? Use the same list presented in paragraph I above. For each department, understand:
 - a. who are the relevant employees
 - b. what is the reporting hierarchy/organizational chart for those employees?
 - c. what are their roles with respect to international security.
- F. Does the company have ex patriot employees?
 - 1. Who and where are they?
 - 2. What security support does the corporation provide?
 - 3. Who oversees ex pats?
 - 4. How does the corporation communicate with them?

- G. Understand the current insurance program relative to international travel.
 - 1. For each line of insurance:
 - a. who are the brokers, underwriters and security providers,
 - b. what are the limits, basic terms, who is covered
 - c. examples of types of insurance to consider:
 - i. Work Comp (Foreign Jurisdiction)
 - ii. Health Insurance abroad
 - iii. Kidnap & Ransom Insurance
 - iv. Travel Insurance
 - 2. How are ex patriots insured?
 - 3. Is there a current relationship with a security service provider?

Is there coordination between the Security Department and the Risk Management and Insurance Department?

3. What is management's position toward managing and insuring the risks of international travel (e.g. currently in a state of denial or ready for action, tight budget or whatever it takes; minimalist approach or comprehensive)?
