Important Points For China

Patent Licensing - The Market Equalizer

- Patent Licensing allows innovators to recoup investments in new technology development
 - Without licensing fees to equalize, non-innovators get an unfair market pricing advantage

Important Points For China

Patent Licensing - The Market Equalizer

- Patent Licensing allows manufacturers to sell products based on new technology without R&D
 - With access to patented innovation, manufacturers that do not have R&D operations can compete in new technology products

Experiences in China The AVS Patent Pool

The Problem

- The AVS Standard covers Audio, Video, DRM and Systems.
 - The Problems:
 - Inadequate IPR Policy.
 - Stated intent to collect no more than 1 RMB (12 cents) for all patents,
 - Limited knowledge as to how patent pools work.

The Solution - Part 1

- Created an IPR Experts Ad Hoc Group that:
 - Rewrote the IPR policy.
 - Build trust.

The Solution - Part 2

- If you can't beat them guide them
 - Member of the AVS Patent Pool Administration Executive Committee.

The Goal

 As the first true patent pool in China, we want to see this pool follow best practices, as it will likely be a model for others.
